# REACH Statement

**Regulation (EG) No. 1907 / 2006 (REACH)**

Dear Ladies and Gentlemen,

With this letter we inform you that the products supplied by us do not contain substances of very high concern (SVHC) above 0,1%, of the list of candidates according to Art.33 of the REACH Regulation (Regulation (EG) No. 1907/2006). We also comply with the "Regulation (EU) 2018/1881 of December 03, 2018 amending Annexes I, III, VI, VII, VIII, IX, X, XI and XII of Regulation (EC) No. 1907/2006 of the European Parliament and of the Council on the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) with a view to the nanoforming of substances."

The EU suppliers of products that are processed into our products in a relevant degree are also obliged to inform us unsolicited, if the products they supply, contain a SVHC substance above 0,1%. If we receive information from our suppliers and learn that our products exceed the 0,1 mass percentage threshold for a SVHC substance, we will inform you immediately.

We ask our EU suppliers to comply with their obligations to inform us voluntarily and without delay if a delivered product contains a substance of very high concern (SVHC) in a mass concentration above 0,1%.

With all non-EU suppliers we make separate arrangements, as they are not automatically subject to the REACH information requirements. Non-EU suppliers have to inform us in writing if the delivered product contains a substance of very high concern (SVHC) in a mass concentration above 0,1 %.
